Thus, SASF has the absolute right, title, interest and authority to recover all the monies owed by the Borrower to IDBI and to enforce the securities created by the Borrower in favor of IDBI. Therefore, for all the practical purposes, SASF would be treated as if it has stepped into the shoes of IDBI.
